YOUTH DEVELOPMENT ACADEMY (YDA)

WORKGROUPS

- ▶ Treatment Programs/Individual Rehabilitation Program
- ▶ Court Operations
- ▶ Facility Operations
- ▶ Reentry
- ▶ Data

TREATMENT WORKGROUP & INDIVIDUALIZED REHABILITATION PLAN

- ▶ Ongoing discussions with BHS
- ▶ Procurement under development (subject to outcome of BHS talks)
- ▶ MDT process develops IRP utilizing SDRRC-II, input from youth and family, BHS, Education, Probation
- ▶ IRP presented in court within 30 days of commitment
- ▶ Review Hearing every six months to update the parties on youth's progress

FACILITY OPS WORKGROUP

- ▶ Selected units Golf and Juliet
- ▶ Identified programming and meeting space
- ▶ Investigating expanded incentives
- ▶ Ways to structure the day for youth who have finished school
- ▶ Would like to see additional clinicians for this population similar to HOPE
- ▶ Potential challenges related to CTE space during KMJDF/YTC Phase II

FACILITY IMPROVEMENTS

- ▶ Working with DGS to develop cost estimate to make two units more homelike and livable for longer commitments
- ▶ Resurfacing or replacing sleeping room doors
- ▶ Painting walls,
- ▶ Resurfacing concrete floors in sleeping rooms,
- ▶ Homelike (but heavy duty) furniture,
- ▶ Area rugs for two living spaces in each day room,
- ▶ Large photo murals of local outdoor scenes,
- ▶ Removal of upper bunks

REENTRY WORKGROUP

- ▶ Reviewed the YOU case planning workflow – referred to team for Individualized Rehabilitation Plan
- ▶ Recommends hiring the parent of a former system involved youth as parent liaison
- ▶ Recommends adding restorative practice elements to MDT and planning meetings

DATA WORKGROUP

- ▶ Recommendations contributed to two of the responses in our plan
- ▶ Addressing data system updates related to naming the program

COURT OPS WORKGROUP

- ▶ General support for court report format
- ▶ Connected to field service for review of court report format and revision of report recommendations
- ▶ Members separately provided input to the Individualized Rehabilitation Plan
- ▶ Discussed expectation that the IRP will be delivered to the Court, DA, and PD within 30 days of commitment and will be addressed by all parties in a review hearing. The Court and all parties will receive an update at six-month review hearings.

- ▶ **9/13/2021 – Present at BOS Meeting for Approval**
- ▶ **1/1/2022 – Deadline to Submit Approved Annual Plan to OYCR**

NEXT STEPS

- ▶ Develop phased behavior program to connect to DAS and inform decisions about step down and furloughs
- ▶ Continue to develop the Individualized Rehabilitation Plan
- ▶ Identify the position to coordinate the MDT process which develops the IRP
- ▶ Establish agreements with BHS, local college(s), and procure additional services
- ▶ Finalize the court report format and recommendations
